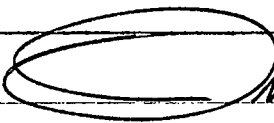

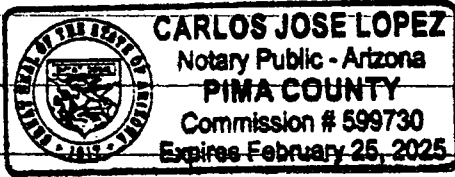

<b>N A R R A T I V E</b>	<b>1</b>	<p><b>Topic</b> ORIGINAL REPORT</p> <p>This investigation was audio recorded...</p> <p><b>Synopsis:</b></p> <p>On 02-23-12 at approximately 1220 hours, Donna Smith and MarcheLe Miller engaged in a verbal argument with one another and were subsequently arrested for Disorderly Conduct - Domestic Violence at the location of 855 N. Dobson Rd., Chandler.</p> <p><b>Narrative:</b></p> <p>On 02-23-12 at approximately 1220 hours I was dispatched to the location of 855 N. Dobson Rd. #1009 reference a fight between two female subjects, one of which being a [REDACTED]. Prior to my arrival I was advised several subjects were involved, described as a white male, two white females and black female. While enroute to the location I was advised by Officer Angel Chavez, two of the parties involved (white male and white female) left the parking lot of the apartment complex in a white Jeep Cherokee and was last seen traveling northbound on Dobson Rd. toward Ray Rd. I was traveling southbound on Dobson from Warner Rd. and located the white Cherokee northbound. I turned around and conducted a traffic stop on the vehicle to which it yielded at the intersection of Highland St. and Dobson Rd. I contacted the occupants of the vehicle from the passenger side and asked for identification, at the same time asked what was going on. The driver provided me an Arizona Drivers license identifying him as Albert Smith, stating "Lover's quarrel". The passenger was identified via Arizona Drivers License as Donna Smith. I asked Donna to step out of the vehicle so I may speak with her in private.</p> <p>While speaking with Donna, I asked her what was going on and she told me she and the lady her husband has been sleeping with got into a verbal altercation about the affair they have been having. Donna continued and stated she didn't know exactly what had happened because it all happened so fast and was still pretty "worked up" about it all. I asked Donna if she was injured at all and she said she was not. I noticed Donna had slight redness and asked how that happened. Again Donna said she did not know exactly what transpired, however knew she "got into it" with "Marchele Miller".</p> <p>It was decided I would escort Albert and Donna Smith back to the apartment complex where this incident initiated and we would sort it out from there. Upon arrival at 855 N. Dobson Rd., Officer Angel Chavez was speaking with the other half of the party, identified as MarcheLe Miller and Darline Maitland. I re-contacted Donna and asked her what happened today and she advised me the following:</p> <p><b>INTERVIEW: (Donna Smith)</b></p> <p>Donna provided a brief history of the relationship between herself, Albert Smith and MarcheLe Miller: Three years ago, the three of them were involved in a consented three way relationship living together and engaging in sexual activity together. After the three year relationship, Donna decided not to include MarcheLe in their marriage any longer and MarcheLe moved out. However during the three year separation, Albert continued his sexual relationship with MarcheLe without Donna's consent, and Donna would catch Albert in his extra marital affair from time to time (approximately 5 different locations). Donna finally had enough and threatened Albert with a final separation and/or divorce if he did not end</p>

his affair. Albert agreed to end his relationship with MarcheLe whom then asked for her cell phone and key to her apartment back.

Today, Donna arrived in the parking lot of MarcheLe's complex as a passenger with Albert and waited inside the vehicle as Albert returned the items. Donna said Albert was inside MarcheLe's apartment for approximately 5 minutes and she grew very anxious and angry about it. Donna then exited the vehicle and walked to MarcheLe's apartment door. Before she could knock, Albert opened the door to MarcheLe's apartment and immediately Donna and MarcheLe began arguing and yelling at one another consisting of "a lot of name calling and pointing fingers". Albert and MarcheLe's friend, Darline assisted in restraining the two of them from continuing the altercation prohibiting it from getting physical. Donna said she was restrained "held back" and eventually escorted back to the vehicle and left the parking lot with Albert. I asked Donna if at any time, there was physical contact between she and MarcheLe and Donna said there was not.

### INTERVIEW: (Darline Maitland)

I asked Darline to provide me a statement regarding the incident and she advised the following: Darline was seated inside her vehicle located approximately 30 yards northeast from MarcheLe's apartment door. Albert was inside MarcheLe's apartment, and approximately 5 minutes later, watched as Donna walked up to the door. Darline stated as the apartment door opened, there was an immediate verbal altercation between Donna and MarcheLe and Albert was attempting to restrain Donna from entering the apartment. Darline exited her vehicle and approached the three of them whom were now near the stair well of MarcheLe's apartment door (approximately 15 feet away). Darline assisted by restraining Donna from any further advancement towards MarcheLe as Albert was restraining MarcheLe from advancing on Donna. I asked Darline if there was any physical contact between Donna and MarcheLe and Darline said there was not.

### INTERVIEW: (Marchele Miller)

After speaking with Albert and receiving her requested items, Albert opened her apartment door and Donna was standing outside stating it "Doesn't take this long to returned a cell phone". Donna then began yelling at MarcheLe and MarcheLe approached Donna while Albert was standing between the two. MarcheLe stated, Donna then balled up her fist, swung around Albert and struck her in the bottom lip.

NOTE: Albert is a large individual, standing approximately 6'00" tall 240lbs. with a very broad stature. I looked at MarcheLe's bottom lip and did not observe any injury consistent with that of having been punched with a closed fist.

I asked MarcheLe if she knew which hand Donna struck her with and she did not know, however knew she was struck in the lip because she remembered feeling a sense of "shock". I asked MarcheLe, with Albert standing in the middle of the two, how Albert held the both of them back, and MarcheLe described it as "he may have raised his hands".

Albert then grabbed Donna in a "bear hug" and walked he approximately 12 feet away from the door, as MarcheLe advanced in the direction of Albert and Donna. At one point Donna escaped Albert's hold and was then restrained by Darline who was telling Donna to stop, at the same time, Albert was now holding MarcheLe back from advancing on Donna. Albert eventually got a hold of Donna once again and took

he back to the vehicle where they both left. I asked MarcheLe if she continued yelling at Donna and she admitted she did yell at her, calling her white trash and telling her to leave.

INTERVIEW: (Brittany Lawson)

I spoke with Brittany about what she had witnessed during the incident and she advised the following:

Brittany was on her balcony smoking a cigarette when she heard two different female voices yelling at one another. When Brittany looked down, she observed Donna Smith arguing with either Darline or MarcheLe. This was taking place approximately 40 feet from the apartment door where Albert was attempting to separate MarcheLe and Donna. I asked if it appeared the two of them were wanting to fight one another and Brittany stated it seemed as if Donna was being the aggressor as MarcheLe was attempting to back away. I asked Brittany if she witnessed either MarcheLe or Donna strike on another and she did not.

Due to the investigation conducted and the totality of the circumstances, it was apparent this "love triangle" or previous "threesome" had reached a breaking point Donna did approve of. She made an overt action by taking the steps to approach MarcheLe's apartment door, to either order Albert back to the vehicle and/or engage in disruptive behavior with MarcheLe. Although this was primarily a verbal altercation (with the potential of it being physical if it were not for the intervention of Albert and Darline) it was the decision of my immediate supervisor (Sergeant Wilkins) to arrest both Donna Smith and MarcheLe Miller for Disorderly Conduct - Domestic Violence.

Both Donna and MarcheLe were transported to the Chandler City Court where they were seen by a Chandler City Court Judge for their Initial appearance.
